Annual School Integrated Pest Management Notification For Audubon School District

As part of a school pest management plan, *Audubon School District* may use pesticides to control pests. The United States Environmental Protection Agency (EPA) and the New Jersey Department of Environmental Protection (DEP) registers pesticides to determine that the use of a pesticide in accordance with instructions printed on the label does not pose an unreasonable risk to human health and the environment. Nevertheless, the EPA and DEP cannot guarantee that registered pesticides do not pose any risk to human health, thus unnecessary exposure to pesticides should be avoided. The EPA has issued the statement that where possible, persons who are potentially sensitive, such as pregnant women, infants and children, should avoid unnecessary pesticide exposure.

The following is a list of any pesticide(s) in use or used in the last 12 months on school property:

- Dupont Advion Roach Gel Bait
- Dupont Advion Ant Gel Bait
- Avert Dry Flowable Roach Bait
- General Point Source

- Alpine Pressurized Fly Bait
- Final Blox

Our school district has designated an Integrated Pest Management (IPM) Coordinator, and that Coordinator maintains the product label and material safety data sheet, when available, of each pesticide that may be used on school property. The label and data sheet is available for review by a parent, guardian, staff member, or student attending the school.
